3. **Age Limit:** (a) Not less than 18 years of age and not more than 38 years of age as on 01.01.2024. Provided that in case of Scheduled Castes, Scheduled Tribes and Other Backward Classes, there shall be relaxation in upper age limit as per State Government norms.

(b) All appointments shall be temporary for a period of one year.

4. **Medical Fitness:** No person shall be appointed to any post without medical certificate of fitness being granted by a Registered Medical Practitioner or as the Appointing Authority may approve.
